In the letter (1) cited the UGC, New Delhi has agreed to confer Autonomy to Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District from the Academic year 2012-13 to 2017-18.

In this connection, I am by direction of Hon'ble Vice - Chancellor, JNTUK Kakinada happy to convey the conferment of Autonomy on "Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District" from the Academic year 2012-13 to 2017-18, subject to fulfillment of the following conditions:

- Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- The students presently enrolled in the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, shall continue to be governed by the academic regulations of JNTU Kakinada.
- The admission procedures to be followed by the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District shall continue to remain the same as those of APSICHE/JNTUK for various programs run by it even after acquiring autonomous status.




- d. The autonomous status for the Prasad V. Potluri Siddhartha Institute of Technology, Kanuru, Vijayawada, Krishna District, shall come into force with effect from the academic year 2012-13.
- e. The college shall follow the guidelines issued by the UGC in all matters.
- f. The college shall constitute the necessary Statutory Bodies and inform the University.
- g. There shall be no financial commitment on the part of JNTUK and the college shall continue to pay all administrative/affiliation fees due to the University as usual.
- h. These orders are issued subject to ratification by the Monitoring & Development Committee of JNTUK.
