Sri D. Rama Krishna made the following suggestions:

- To raise the ranking position of the Institution, more number of Students may be encouraged to go
 on Internship.
- 2. Reasons may be analyzed for lesser demand of M.Tech and the Institution shall enter into linkage with Industry to increase the scope for Internship.
- 3. Focus might be laid on enhancing the coding capabilities of Students.
- 4. Faculty need to gain adequate exposure and should develop an inclination for Research.

President SAGTE made the following suggestions:

1. Research should be need based and should solve the practical problems in the society.

Dr.Swarna Kumari opined

- Collaborative projects have to be taken up by the Faculty and Students. She emphasized the need for enhancing the coding skills.
- 2. It is advised that more Computer Branches may be started whereas the core Branches may be decreased.

20. Response by the Principal

Addressing the Points, Dr.K.Sivaji Babu, Principal brought to the notice of all the Members that the following are the measures taken towards enhancement of Quality:

- 1. Internship is made mandatory for UG Students from the A.Y. 2020-21 under PVP 20 Regulations.
- 2. Final Semester is totally allocated for Projects.
- 3. Innovative Methods of Training are being adopted from the current Academic Year and the Services of Industry personnel are utilized for providing better training and increasing Quality Placements. Unlike the previous years, Training shall be given from the Second Year onwards, to increase the coding capabilities of Students.
- 4. He added that JNTUK has granted permission to the Institution for issuing the Provisional Certificates to the Students.
- The Management has taken a decision to review the performance of Professors and Associate Professors with an aim to inculcate in them the passion for Research..

The chairman thanked all the members of the Governing Body for their gracious presence and fruitful discussion and with this, the meeting came to an end.
