Principal informed that there are no court cases pending with the Government or AICTE.

17. Suggestions given by the Members.

- D.Rama Krishna, Industrialist Nominee advised that there is an immense need to
 observe the changing global scenario. He opined that in the near future most of the
 mediocre Jobs would be lost and the service Organizations may be affected. Hence,
 the Faculty should be well versed and well equipped with the emerging trends in
 Technology.
- D.Rama Krishna Suggested that M.Tech Syllabus should be designed keeping in view the Market demand. He expressed that Industry oriented syllabus would lead to employment generation.

- Thrust should be laid in the emerging areas viz Data Analytics, Arm Processors, 3D
 Printing, Robotics and Automation so that employment opportunities would be
 increased.
- Prof.K.Ramu, University Nominee opined that the pass percentage in Civil is less and attributed it to the poor academic background of Students opting for that Branch.
- 5. S.Vishnu emphasized the need of training for Faculty.

Resolutions:

- Principal of the College said that an Awareness Meet shall be arranged by the Institution. D.Rama Krishna, M.D Efftronics and G.Venkateswara Rao, Sr.Vice President, Tech Mahindra shall provide necessary inputs.
- 2. Principal assured that more care shall be taken and sincere efforts need to be laid by the Faculty for providing necessary academic support for the Students so that the pass percentage in the core Branches would be improved. Steps will be taken to revise the syllabus in tune with the Industry requirements as per the suggestions made by the members.
- 3. Principal brought to the notice of all the members that a training programme has been planned in collaboration with Veda IIT and added that more number of Students of IV B.Tech may be provided with Internships which would enable the Students to apply Technology to solve real life problems. He further stated that all the necessary measures for the betterment of Quality will be taken and assured that all the suggestions provided by the Members shall be incorporated during the revision of Curriculum.

The Principal thanked all the members for their presence and invaluable suggestions provided for the sustenance of Quality. With this, the Meeting ended.
